Air Quality during Fire Season

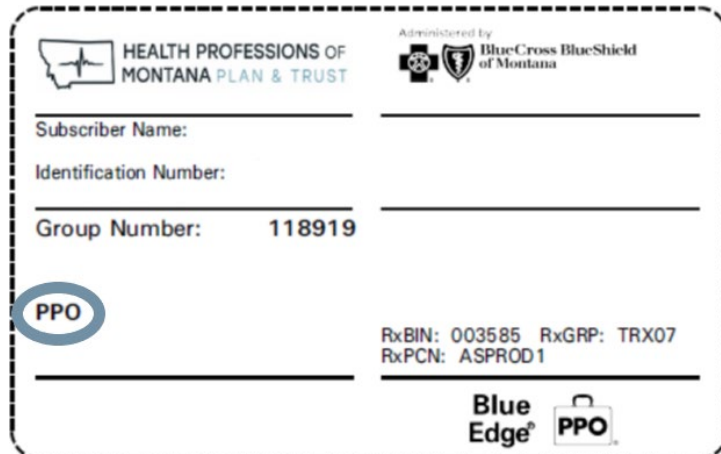
