My interest in the MMAHCPT was initially spurred around the time of its inception by an announcement made by Tim McInnis, MD to a meeting of the general medical staff at Bozeman Health (formerly Bozeman Deaconess). He, along with Bruce Robertson, MD and other members of the MMA Executive committee were developing an association health plan "designed by



physicians for physicians". As a psychiatrist in a new private practice, having previously worked for several years as an employee in a community mental health center, I was intrigued by this unique physician-directed plan. I was looking for a health insurance plan that provided affordable and comprehensive care (pre- "essential health benefits") as well as a product that I could ethically support (pre-"mental health parity"). Soon after my first meeting with our plan executive extraordinaire, Marcy McLean, I became the second practice to join on with the MMAHCPT.

My participation as a board member of MMAHCPT happened quite unexpectedly. After making a call to our plan chairman Bruce Robertson, MD inquiring about announced changes to the plan's COBRA that would impact my practice, Bruce responded in a very direct and to the point manner (anyone who knows him would not expect otherwise). He gave me a comprehensive and academic explanation to my question detailing changes in federal regulations followed by a strong suggestion that I consider assuming an open position on the board if I wanted to be part of influencing the direction of the MMAHCPT in the future. Approximately 9 years have passed since accepting my position on the Board of Trustees and the Sponsor Organization Board of the Montana Medical Association Health Care Plan and Trust (MMAHCPT).

DID YOU KNOW?

 As a member of MMAHCPT, you have access to Blue Cross Blue Shield of Montana's Condition Management program at no cost to you. A Blue Care Advisor who is a licensed clinician can help you manage your health condition such as depression, diabetes, asthma, low back pain, congestive heart failure and many more.  You can track your personal claims, print ID cards, find providers, track your copay and deductibles, check drug prices, find the full benefit plan booklet for MMAHCPT, etc. online with BCBSMT and our pharmacy provider, MedImpact. • If your employer elected to offer dental and vision insurance to employees, you should have SEPARATE insurance cards for those benefits. If you give your eye care provider or your dentist your regular MMAHCPT health insurance card, your claim will not be billed correctly and will be denied.

• The MMAHCPT launched the Total Health Management program at no charge to our members in February. All members and spouses (on the MMA Health Plan) who sucessfully complete the THM form and return to BCBSMT will receive \$100 deductible credit on their 2019 deductible. Your search may also result in big savings and information that gives you more control over health care decisions. Provider Finder shares information such as:

- Do you want to know more about the doctors who take care of you or your family?
- Do you need to know the estimated cost of a medical service?
- Do you want to find savings by comparing costs?
